

**7-ELEVEN / DALLAS MAVERICKS SWEEPSTAKES (“SWEEPSTAKES”)
OFFICIAL RULES**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY: Sweepstakes is open only to legal U.S. residents residing in select Texas zip codes (see Appendix at the bottom of these Official Rules for eligible zip codes) within the Dallas/Fort Worth area who are eighteen (18) years of age or older at time of entry. Employees, officers and directors of 7-Eleven, Inc. (“Sponsor”), Dallas Basketball Limited (the “Dallas Mavericks”), the National Basketball Association (the “NBA”), NBA Properties, Inc., NBA Media Ventures, LLC, and the NBA member teams (collectively, the “NBA Entities”), and each of their respective parent, subsidiary and affiliated companies, owners, partners, members, directors, officers, governors, franchisees, retailers, distributors, representatives, agents, Web design, and advertising and promotion agencies involved in the administration, development, fulfillment and execution of this Sweepstakes (collectively “Sponsor and Promotion Parties”), and each of their respective IRS dependents, immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside), and individuals residing in their same household are not eligible to participate or win. The Sweepstakes is subject to applicable federal, state and local laws and regulations. Sponsor reserves the right, at any time, to verify eligibility requirements in any manner it deems appropriate. By participating, participants agree to these Official Rules, which are final and binding in all respects. Void outside of the eligibility area and where prohibited or restricted by law.

2. SWEEPSTAKES PERIOD: Sweepstakes begins at 12:00:00 a.m. Central Time (“CT”) on April 1, 2022 and ends at 11:59:59 p.m. CT on June 30, 2022 (“Sweepstakes Period”). The Sweepstakes Period consists of three (3) entry periods (each an “Entry Period”) as outlined in the table below. Each Entry Period begins on the Start Date listed in the table below at 12:00:00 a.m. CT and ends on the End Date listed in the table below at 11:59:59 p.m. CT. The time clock of the computer administering this Sweepstakes is the official timekeeping device for this Sweepstakes.

3. HOW TO ENTER: There are two (2) ways to enter the Sweepstakes:

(a) 7-Eleven, Inc. App with purchase: The 7-Eleven App is required for this method of entry. Eligible participants must present and have their 7-Eleven App scanned at a participating 7-Eleven (see Appendix at the bottom of these Official Rules for a list of participating locations) during traditional, e-wallet or mobile checkout of any one or more product(s) sold at 7-Eleven (excluding alcohol, tobacco, and lottery tickets) to automatically receive one (1) entry into the corresponding Entry Period Drawing and Grand Prize Drawing (both defined in Section 4).

The 7-Eleven App can be obtained for free by visiting Google Play or the iTunes App store and downloading the 7-Eleven App to a web-enabled iOS 11 or Android 5.0 (or higher) mobile device, then following the in-app instructions to complete an account profile. Registered 7-Eleven App users are automatically enrolled in 7Rewards. Data rates may apply. Participation in 7Rewards and use of the 7-Eleven App are subject to Sponsor’s Terms, available at <https://www.7-eleven.com/terms> and Privacy Policy, linked in Section 6 below. **For 7-Eleven App entries, participants must fully and accurately complete the registration process for the 7-Eleven App and be opted-in to receive marketing communications from 7-Eleven if participating via the 7-Eleven App.**

Rewards points may still be accumulated for 7-Eleven App, 7Rewards card, and CFD scans that exceed the entry limitation, but no additional Sweepstakes entries will be awarded for those scans. The participant must be the authorized account holder of the registered 7Rewards account associated with the entry. In the event of a dispute over the identity of a participant or potential winner in the Sweepstakes, the participant or potential winner will be deemed the authorized account holder of the email address associated with the 7Rewards account. “Authorized Account Holder” is defined as the natural person in whose name the email account was opened, as long as such person is otherwise eligible in accordance with these Official Rules. Entries will not be acknowledged except as provided herein.

(b) Mail-in: To enter without making a purchase, hand print your first and last name, complete mailing address (no PO Boxes), daytime phone number, date of birth, and email address on a 3” x 5” index card or piece of paper and place your entry into an outer-mailing envelope with proper postage affixed and mail it to: 7-Eleven / Dallas Mavericks Sweepstakes, c/o GSE, PO Box 130, Dept. 22-8122-02, Glencoe, MN 55336-0130. Any entry postmarked in compliance with Section 2 but not received by the Mail-in Entry Received By Date set forth therein, will be entered into the next Entry Period Drawing (if any) and the Grand Prize Drawing. See Section 4 for drawing details. No photocopied or mechanically reproduced entries accepted. Limit one (1) entry per outer-mailing envelope. Sponsor and Promotion Parties are not responsible for lost, late, damaged, illegible, misdirected or postage-due mailed entries. Entries become property of Sponsor and will not be returned.

There is no limit to the number of entries a participant can submit, however, all entries must be submitted in accordance with these Official Rules.

4. RANDOM DRAWINGS: Entry Period Drawings: Potential First and Second Prize winners will be selected for each Entry Period in a random drawing on or about each Drawing Date listed in Section 2 from among all eligible entries received for the corresponding Entry Period (each an “Entry Period Drawing”). Entries will not carry forward to subsequent Entry Period Drawings; however, all entries will carry forward to the Grand Prize Drawing. See Section 5 for the number of First and Second Prizes awarded per Entry Period. **Grand Prize Drawing:** The potential Grand Prize winner will be selected on or about July 8, 2022 from among all eligible entries received for the entire Sweepstakes Period (“Grand Prize Drawing”). First Prizes (11 total; awarded 3 for Entry Period 1 and 4 for Entry Periods 2 and 3): One (1) autographed Dallas Mavericks jersey. ARV: \$150.00 each.

Second Prizes (12 total; awarded 4 per Entry Period): One (1) autographed basketball. ARV: \$150.00 each.

Total ARV of all prizes: \$4,000.00.

Grand Prize conditions: All transportation, accommodations, parking, meals, gratuities, and all other expenses not specified herein are solely the winner’s responsibility. Exact date and time of the Experience to be determined by the Dallas Mavericks at a later date, in its sole discretion. Experience is subject to availability, change, and/or cancellation. If winner cannot attend the Experience on the date specified, prize shall be forfeited and Sponsor shall have no further obligation to such individual. An “NBA Legend” means any former NBA player, member of the coaching staff, broadcaster and/or basketball executive. Winner acknowledges that the selection of the NBA Legend who shall be available to make such appearances shall be determined in the sole discretion of Dallas Mavericks and may be limited by several factors, including without limitation, individual availability and preferences. Winner’s guest(s), if any, must be of legal age of majority in his/her (their) jurisdiction(s) of residence (and at least eighteen (18) years of age). Additional prize details may be provided to the winner at the time of notification. Prize is not for re-sale and cannot be sold after awarded. Sponsor and the NBA Entities are not liable for any missed events or opportunities or expenses incurred as a consequence of any transportation delay or in the event winner and/or a guest is late to the Experience (through no fault of Sponsor or due to Force Majeure Event). Winner agrees to comply with all NBA Entities’ and venue policies and regulations, including without limitation all health and safety protocols at all times. Persons who tamper with or abuse any aspect of this Sweepstakes or otherwise attempt to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair playing practices or intending to annoy, abuse, threaten or harass any other participants or Sponsor representatives, as solely determined by the Sponsor, will be disqualified. Any use of robotic, automatic, macro, programmed or like methods of submitting an entry will void all such entries by such methods, and disqualify any participant using such methods. Released Parties are not responsible for injury or damage to participant's or to any other person's computer or mobile device related to or resulting from participating in this Sweepstakes or downloading materials from or use of the 7-Eleven App. Should any portion of the Sweepstakes be, in Sponsor's or Sponsor and Promotion Parties' sole opinion, compromised by virus, worms,

bugs, non-authorized human intervention, technical failures or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or submission of entries, Sponsor and NBA Entities reserve the right, at their sole discretion, to suspend, modify or terminate the Sweepstakes, and select the potential winner(s) in a random drawing from all non-suspect, eligible entries received prior to action taken or as otherwise deemed fair and appropriate by Sponsor. Released Parties are not responsible for any incorrect or inaccurate information, whether caused by users of the 7-Eleven App, human error, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes, and assume no responsibility for any error, interruption, deletion, defect, delay in operation, or transmission, communications line failure, theft or destruction, or unauthorized use of the 7-Eleven App.

CAUTION: ANY ATTEMPT BY ANY PERSON TO DELIBERATELY DAMAGE THE 7-ELEVEN APP OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR AND NBA ENTITIES RESERVE THE RIGHT TO DISQUALIFY AND SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

BINDING ARBITRATION: Any controversy or claim arising out of or relating to this Sweepstakes shall be settled by binding arbitration in a location determined by the arbitrator as set forth herein (provided that such location is reasonably convenient for claimant), or at such other location as may be mutually agreed upon by the parties, in accordance with the procedural rules for commercial disputes set forth in the Comprehensive Arbitration Rules and Procedures of JAMS (“JAMS Rules and Procedures”) then prevailing, and judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. The arbitrator shall be selected pursuant to the JAMS Rules and Procedures. The arbitrator shall apply Texas law consistent with the Federal Arbitration Act and applicable statutes of limitations, and shall honor claims of privilege recognized at law. In the event that the claimant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, Sponsor will pay as much of the claimant’s filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive. If any part of this arbitration provision is deemed to be invalid, unenforceable or illegal (other than that claims will not be arbitrated on a class or representative basis), or otherwise conflicts with the rules and procedures established by JAMS, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein. If, however, the portion that is deemed invalid, unenforceable or illegal is that claims will not be arbitrated on a class or representative basis, then the entirety of this arbitration provision shall be null and void, and neither claimant nor Sponsor shall be entitled to arbitrate their dispute. Upon filing a demand for arbitration, all parties to such arbitration shall have the right of discovery, which discovery shall be completed within sixty (60) days after the demand for arbitration is made, unless further extended by mutual agreement of the parties. **THE ARBITRATION OF DISPUTES PURSUANT TO THIS PARAGRAPH SHALL BE IN THE PARTICIPANT’S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. THE ARBITRATOR MAY NOT CONSOLIDATE OR JOIN THE CLAIMS OF OTHER PERSONS OR PARTIES WHO MAY BE SIMILARLY SITUATED. DO NOT ENTER THIS SWEEPSTAKES IF YOU DO NOT AGREE TO HAVE ANY CLAIM OR CONTROVERSY ARBITRATED IN ACCORDANCE WITH THESE OFFICIAL RULES.**

SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO EVERY PARTICIPANT.

10. GOVERNING LAW AND JURISDICTION: By participating, participants agree that all issues and questions

concerning the construction, validity, interpretation and enforceability of these Official Rules, participant’s rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Texas without giving effect to any choice of law or conflict of law rules, and any matters or proceedings which are not subject to arbitration as set forth in these Official Rules and/or for entering any judgment on an arbitration award, shall take place in the State of Texas, in Dallas, Texas. By participating, participants consent to the jurisdiction and venue of the federal, state and local courts located in Dallas, Texas.
